# **About the Course**

#### **Course Overview**

This two day course provides participants with an understanding of the Basic Aviation Risk Standard (BAR Standard) and how it can be used by resources sector personnel to help identify potential aviation safety risks. Participants will be able to use knowledge gained on the course to review their company's aviation management policies & procedures and formulate appropriate risk management strategies to manage identified day-to-day risks.

The course covers two primary modules: (i) the basic principles of flight and aviation operations ("Aviation 101"); and (ii) an outline of the BAR Standard.

# Who Should Attend This Course

The Aviation Coordinator Course has been developed for personnel involved with the management and operations of their company's contracted aviation services. Eligible attendees include:

- mine/site/asset managers;
- contract administrators;
- corporate assurance/risk managers;
- onsite accountable persons;
- executive managers (with accountability for decisions that directly impact on the selection of aviation service providers); and
- all personnel who are involved in aviation operations as part of their day-to-day activities.

#### **Course Objectives**

The objectives of the course are to:

- introduce participants to the basic principles of flight and aviation operations ("Aviation 101");
- provide a detailed overview of the overall BARS Program and the BAR Standard;
- explain basic aviation risk management principles;
- provide guidance on the unique role of a resources sector Aviation Coordinator;
- provide an explanation of the distinction between the roles of Aviation Coordinators and Specialist Aviation Safety Advisors;
- explain frequently used aviation industry terms;
- provide an introduction to resource sector aviation operations for personnel without an aviation background;
- assist participants in being able to identify potential risks and threats to the safety of their company's aviation operations;
- provide a range of tools that assist resources sector personnel identify hazards specific to the aviation industry.

#### **Course Facilitator – Geoff Roberts**

The Foundation has engaged Geoff Roberts, principal of Arrius Pty Ltd (a specialized aviation safety training organization) as chief facilitator of the course. Geoff has extensive skills and experience in both a fixed and rotary wing flying and instructing; flight safety programs; incident and accident investigation; aviation/airline management; regulatory affairs; and resource sector aviation safety management and auditing.



Geoff began his aviation career in 1983 as a trainee Royal Australian Air Force (RAAF) pilot. Following graduation, he spent the next three years operating helicopters in a variety of Australian and overseas locations.

In 1987 Geoff became a flying instructor and spent two years instructing basic students in both military and civilian flying roles. This was followed by tour as a staff instructor at the RAAF Central Flying School, where duties included advanced instruction of students, standardization of flight crew on a variety of fixed and rotary wing aircraft and flying with the "Roulettes" – the RAAF aerobatic team.

Geoff spent the next seven years at the RAAF Aircraft Research and Development Unit in a standardization role and continued work as a Flight Safety Officer.

In 1999, Geoff joined BHP Aviation as the Technical Officer and then Aviation Adviser, conducting operational and technical reviews of aviation companies providing support to BHP worldwide.

On leaving BHP, Geoff worked for Kendell Airlines and National Jet Systems (now Cobham) in Australia in a variety of line-pilot and management positions, including four years as General Manager Flight Operations, where he was responsible for overall management of the airline operation, which included overseeing the introduction of the Boeing 717 aircraft into the fleet.
